RULES & REGULATIONS:

1. Bicycles will NOT be ridden on the fairgrounds except during the parade.
2. Helmets MUST be worn at all times when riding in the parade.
3. ONLY human - powered! Two or Three wheeled bicycles and scooters will be allowed to compete and participate in the parade. Training wheels are ok. ABSOLUTELY NO MOTORIZED VEHICLES! (INCLUDING ELECTRIC CARS, BIKES OR SCOOTERS.)
4. Registration is to be mailed or dropped off at the fairgrounds. Pre-fair entry is not mandatory but is suggested before July 30, 2019.
5. Decorations must be completed before arrival at the fairgrounds, and attached FIRMLY
6. Decorations must not interfere with safe operation of the bicycle or scooter
7. All children in the contest must be accompanied by an adult
8. Parade will be at 12 pm on Sunday and check-in will be at any time before 11:30 am on Sunday at the entrance of the fair and the bicycle will be on display near the fair office before the parade. Parade route and lineup will be given at this point.
9. Prizes will be awarded for first place in each category and everyone will receive a certificate of participation.
10. Judging will take place during the parade and all decisions made by Kendall County Fair Assn & judges will be final
11. Awards will be immediately following the parade at family stage 2.
12. Participant will receive gate entry with the \$5 fee everyone else will pay gate admission upon arrival at the fair.
